Production Process:

1. Disperse Konjac Mannan gel powder and Genuvisco carrageenan CG-31 in Glycerin. Add slowly water and mix well. Heat phase A up to 70°C.
2. During heating add phase B to phase A under stirring (paddle-mixer).
3. Heat phase C up to 70°C. Add to phase A/B with an Ultra-TURRAX® (~10.000 rpm, ~1 minute) until you get a smooth texture.
4. Cool down under stirring (paddle-mixer).
5. Add phase D below 35°C and homogenize with an Ultra-TURRAX® until you get a smooth texture.
6. Adjust pH ~6,5 with citric acid solution if necessary and cool down to room temperature under stirring (paddle-mixer).
